I understand that as a volunteer of Promiseland Ministries, I may have access to data, files, records, documents and conversations, which are confidential and/or proprietary in nature. This access may include the ability to update/change/copy, files or records. Access may be directly authorized and controlled through electronic media such as microcomputers, file servers, computer terminals or voice communications which may utilize a unique access ID and/or password. I will to the best of my ability, take all necessary precautions to maintain the confidentiality and integrity of all client files and records.

I also understand that as a volunteer I may handle confidential information regarding clients, organizations, providers and/or employees; including but not limited to personal and financial information. All of such information must be treated with the strictest of confidence.

I recognize that by reason of my routine duties, I may come into the possession of information concerning the services performed by and for a client, even though I may not take any direct part in or furnish the services performed for a client. I agree that, except as directed by the agency, I will not at anytime, during or after my employment with this agency, disclose any such information to any person whatsoever, or permit any person whatsoever to examine or make copies of any reports or other documents in my possession that have in any way to do with a client.

I will take all necessary precautions to safeguard the confidentiality of business related information: personnel: salary, employee health, and all other agency, client or vendor information, unless such information is authorized for release in accordance with Promiseland Ministries policies and/or procedures. Routine safeguards including the proper storage, retention and disposal or organization information will apply. It also includes not discussing any specific aspects of organization information unless in the context of appropriate business transactions.

I understand that the unauthorized access, modification, release and/or disposal of any client information and any contribution to the unauthorized use of such data may result in prosecution under Federal, State, and/or local statues and/or civil litigation, including injunctive relief.

## Philosophy & Policy on Adoption and Parenting

It is important that the staff, Board of Directors and volunteers not give any advice to the young women at Hannah House Maternity Home about whether they should parent or place their child for adoption. Each week they receive counseling from two professional counselors who represent both alternatives and help them develop a plan that is unique to each situation. The birthmother, her parents, sometimes the birthfather and his parents and the counselors work together in this process.

Because the young women are going through a confusing time in their lives, they may change their minds often during the week and months before their due date. Therefore, it is essential that we neither affirm nor discourage any decision a birthmother may voluntarily verbalize. We ask that volunteers not question them nor initiate conversation on this topic. In the event a birthmother should volunteer any information on this topic, lovingly tell her that you will pray for her and know that God will direct her in her decision.

### ***Adoption Policy for Board Members, Staff and Volunteers:***

The staff, volunteers and Board members of the Hannah House ministry will not be allowed to adopt or assume custody of a birthmother or her baby upon birth. Birthmothers can assume temporary shepherding home residency with a volunteer/staff/board member if approved by the Director of Hannah House during the transitional time after the birth of her baby.

Due to the sensitive nature of decisions regarding adoption, it would be a conflict of interest for employees of Promiseland Ministries to pursue adoption while employed by Hannah House. Furthermore, the staff and Board members are not allowed to provide names of couples seeking adoption to birthmothers who are making adoption plans. They can refer their friends and relatives to Chosen Child Adoption Services in Allen, Texas, if they wish to pursue adoption.
